FIRST AID

IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Call a poison control center for treatment advice.

Have the product container or label with you when calling a poison control center or doctor or going for treatment. You may also call 1-800-225-3320 for emergency medical treatment.

PRECAUTIONS

CAUTION: CONTENTS UNDER PRESSURE

Contains 2-propanone (CAS #67-64-1), hydrocarbon propellant (CAS #68476-85-7) and perfume (CAS #NA). Excessive inhalation in confined areas

may cause headaches or dizziness. Avoid spraying directly into eyes and face. Do not install directly over any food handling or dispensing area. Do not allow spray to contact plastic, painted or varnished surfaces. Contents under pressure. Do not use near heat or open flame. Exposure to temperatures above 120°F may cause bursting. Do not puncture or incinerate container.

DIRECTIONS FOR USE

CLEAR ZONE[®] 511 Metered Air Freshener contains a pleasant fragrance plus a highly effective odor counteractant designed for use in most automatic dispensers. The dispenser activates the metered valve every 15 minutes releasing a fine spray of fragrance and odor counteractant that stays suspended in the air for maximum odor control.

HOW TO USE CLEAR ZONE 511 METERED AIR FRESHENER:

Remove cap from top of can and insert can into dispenser in accordance with the dispenser instructions. One dispenser adequately freshens a room up to 30' x 20' x 10'. Position dispenser(s) so that the concentrated spray will not hit people, animals, foods, drinks, feeds, food processing surfaces, or solvent sensitive surfaces including, but not limited to, painted or varnished surfaces. Keep dispenser at least 8 feet away from exposed foods.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

STORAGE: Store in a cool, dry place away from heat or open flame. Do not expose to temperatures above 120°F.

DISPOSAL: DO NOT PUNCTURE OR INCINERATE! If container is empty, offer for recycling. If recycling is not available and if allowed by state and local authorities, discard in trash. If container is partly filled, empty the container by using the product according to the label directions and dispose of as directed above or contact your local solid waste agency for disposal instruction.

Contains no CFCs or other ozone depleting substances. Federal regulations prohibit CFC propellants in aerosols.
