# Q3: What are the active ingredients in Ridesco WG insecticide? What are the benefits of combining them?

Together, the combination delivers rapid upfront activity and powerful performance against a wide range of key pests. ## Q4: What type of formulation is Ridesco WG insecticide? Does it require agitation?

A4: Ridesco WG insecticide is a water-dispersable granule that dissolves/suspends quickly and is easy to mix, measure and store. As a dry formulation, Ridesco WG insecticide does not require agitation of the original container before mixing. After mixing a finished dilution, it is always a best practice to agitate before use.

#### Q5: What is Ridesco WG insecticide's application rate?

**A5:** Ridesco WG insecticide has a simple rate structure, labelled for use at 19 grams / gallon / 1000 sq ft for many pests and sites. Refer to the label for complete details.

#### Q6: What pests does Ridesco WG insecticide protect against?

**A6:** Ridesco WG insecticide delivers powerful protection against a broad range of critical pests including American cockroaches, ants, house flies, spiders, bed bugs and many more. Refer to the label for complete details.

#### Q7: Where can Ridesco WG insecticide be applied?

- A7: With a broad and flexible label, Ridesco WG insecticide is a powerful choice for both outdoor perimeter treatments and interior applications. It allows for Crack & Crevice<sup>®</sup>, spot, and void treatments in and around commercial and residential areas, as well as general area treatments in food-handling areas. Ridesco WG insecticide can also be used on landscapes and lawns, as well as many other application sites.
  - Is Ridesco WG insecticide labeled for use in commercial kitchens? Yes
  - Is Ridesco WG insecticide labeled for use in indoor and outdoor sites? Yes
  - Can Ridesco WG insecticide be used outdoors during precipitation? No. PMPs must wait until precipitation has stopped for outdoor label-supported applications of Ridesco WG insecticide

#### Q8: What is the minimum application interval for Ridesco WG insecticide?

**A8:** The application interval for Ridesco WG insecticide is 7 days.

#### Q9: Is Ridesco WG insecticide a repellent or non-repellent product?

**A9:** Ridesco WG insecticide is a repellent product that effectively forms a barrier against pests wherever it is applied.
